Call to Order: 10:01 a.m.

Treasurer Zuren made a motion to approve the minutes of the February 5, 2024 Budget Commission. The motion was seconded by Prosecutor Coulson.

Vote: All "Ayes".

Home value increases for 2024 tax year payable in 2025 were discussed by Auditor Galloway. It is foreseeable that real estate values will increase 31% for residential and 20% for commercial. Auditor Galloway suggested that the school boards affected should meet and discuss the impact of the additional tax burden on taxpayers and future school levies.

New Business

Auditor Galloway was asked when taxpayers would be notified about their increase of home values. It is estimated to be late July 2024 or early August 2024.
