He explained a few of the changes to this year's revisions; one of which is the addition of PVC piping for use in sanitary lines. Commissioner Troy asked if Mr. Rothlisberger's opinion was that the PVC is as good or better than the traditional clay piping that has been in use. Mr. Rothlisberger stated that the PVC material would be as good or better than clay and also less expensive and less labor intensive to install. County Administrator, Mr. Jason Boyd, reported that this is approving the contract to provide medical services to inmates within the Lake County Jail. He stated that Chief Leonbruno looked into seven providers and recommends a contract with University Hospitals which will be effective April 1, 2018. Mr. Boyd added that ER runs from the jail will continue to Lake Health's TriPoint location. Commissioner Troy stated that the County did receive one 90 day extension on the previous provider. On a motion by Commissioner Troy, seconded by Commissioner Cirino. Port Authority Director of Coastal Development, Mr. Peter Zahirsky, was present and stated that this project will be partially funded by the 2% bed tax, and that the Chagrin River Watershed Partners received a grant from the Cleveland Foundation. He explained that this project will include the installation of an ADA accessible dock and ramp systems for kayaks and canoes at the Erie Road Park and it is a part of the comprehensive master plan. He introduced Ms. Kim Brewster of the Chagrin River Watershed Partners. Ms. Brewster explained that, in addition to the funding from the bed tax, the Chagrin River Watershed Partners received a \$50,000 grant from the Cleveland Foundation for this project. These funds will be used for the installation of permeable pavement and streamside plantings. For clarification purposes, Commissioner Hamercheck stated that the amount requested for this project is \$27,331.75 and there is also a \$50,000 grant from the Cleveland Partnership. Ms. Brewster also stated that they have applied for a \$42,000 grant from ODNR for the installation of a natural playground and some discussion continued on future funding. <u>UTILITIES</u> – Director of Business Operations, Mr. Matthew Armand, stated that customer service is profoundly important to him and today marks the 3 year anniversary of customer service instruction and tracking. He updated the Board on the results of customer service quality. Mr. Armand stated that overall, 79% rate the department as offering excellent customer service, 18% gave a good rating and 1% rated the department as average or poor. Mr. Armand explained that the customer service employees represent the face of the entire Utilities Department and that they strive for great customer service daily.

<u>OLD BUSINESS</u>: - Commissioner Cirino shared with the Board that three of the western communities (Kirtland, Wickliffe, and Willowick) will be finalizing and entering into a shared resources economic development agreement

once they receive council approval at the end of the month. Mr. Zahirsky added that this a great initiative and opportunity for these communities.

NEW BUSINESS: - Commissioner Troy complimented Commissioner Hamercheck on the Northeast District of CCAO event at Perry Nuclear Power Plant. He stated that there was very good representation from the Commissioners of Stark, Ashtabula, Portage, Richland, Geauga and Wayne Counties. There was conversation and explanation on the operation of nuclear plants and the challenges they are facing. CCAO provided lunch and discussed the possibility of hosting another informational session at the Davis Besse Nuclear Power Plant. Commissioner Troy stated that one of the topics discussed at the NACo Annual Legislative Conference in D.C., was the opioid crisis, the increased costs to County budgets, and its effects nationwide. He gave an update on the discussion of the proposed 20% funding from the Federal Government and 80% funding being the responsibility of local governments on the proposed infrastructure bill from the President.

Commissioner Hamercheck thanked the Commissioners Clerk, Ms. Jennifer Bell, for her hard work assisting Ms. Wendy Zele from First Energy with the Perry event. He stated that the Northeast District represents 4.173 million people.

On behalf of the Board of Commissioners, Commissioner Hamercheck offered his condolences to the family of former Lake County Engineer, Mr. Thomas Gilles. Commissioner Troy stated he had the opportunity to work with Mr. Gilles on the SR 615 and I-90 interchange. Mr. Gilles worked very hard and very well with all of the municipalities and corporations to forge the State Route 2 agreement. This agreement was between the County Engineers and all of the incorporated municipalities along Route 2 and it designated the Engineers office to maintain Route 2.

<u>PUBLIC COMMENT</u>: Commissioner Hamercheck asked if anyone in the audience wished to address the Board. Ms. Ellen Chamberlain of Willoughby, asked why #7 on the agenda remains tabled. Commissioner Hamercheck explained that it takes two votes to bring a tabled agenda item back to the table.

EXECUTIVE SESSION: On a motion Commissioner Troy, seconded by Commissioner Cirino, the Board convened an Executive Session at 2:35 p.m. to discuss Personnel – employment and Legal-pending litigation, with the vote as follows: "AYES": Commissioners: Cirino, Hamercheck, and Troy "NAYS": None
