CALL TO ORDER: Commissioner Cirino called the Meeting to order at 10:00 a.m. Tuesday, December 3, 2019.

OPEN TO THE PUBLIC: Commissioner Cirino asked if anyone in the audience wished to address the Board.

Ms. Ellen Chamberlin of Willoughby, stated that at the last Commissioners Meeting, Clerk of Courts, Ms. Maureen Kelly, reviewed a list of expenditures that would utilize the excess funds from license fees and she asked if the money had been distributed to the departments requesting items. Commissioner Cirino responded that Ms. Kelly must officially declare an excess of funds and there was a departmental "wish-list" of sorts which the Board would review the requests before any distributions would be made.

Ms. Chamberlin also discussed recent media advertising she has seen promoting the use of kitchen disposals rather than placing items in the trash. The article stated that it would be better for the environment and air by not placing more items in the landfill. Sanitary Engineer, Mr. Randy Rothlisberger, stated it is much better to throw items away in the trash. He explained that the landfill is equipped to handle all items and there are 100's of wells at the landfill to turn the methane into useful energy to be sold for electricity and heat distribution. He further explained that the sewer lateral between the home and the main is not designed to handle a lot of garbage, especially grease. He stressed that any grease down the pipes may risk plugging those lines. Ms. Chamberlin suggested public education on this issue and also on proper recycling.

Commissioner Hamercheck stated that methane gas is an integral part of the odor control program. Mr. Rothlisberger responded that the County has an EPA Air Quality permit and they must provide monthly reports, in addition they are subject to unannounced inspections by the EPA.
