CALL TO ORDER: Commissioner Plecnik called the Meeting to order at 10:00 a.m. Thursday, May 2, 2024

ROLL CALL: Upon roll being called, Regovich, Hamercheck and Plecnik were present.

APPROVAL OF MINUTES:

Upon a motion by Commissioner Regovich, seconded by Commissioner Hamercheck, the minutes of the Regular Meetings of April 11 and April 18, 2024 were approved with the vote as follows: AYES": Commissioners Regovich, Hamercheck and Plecnik "NAYS": None.

Commissioner Plecnik administered the Oath of Office to Dr. David James Keep as Lake County Coroner.

Mrs. Spencer of Ford Road in Madison reminded the Board of the services she still does not have due to the surrounding road closures. She was told that if everything goes well some of the construction should be completed by the fall of this year (2024).

Rev. Chris Bihary of Painesville, asked that everyone pray for young people, students and families as we recognize the National Day of Prayer.

Ms. Lori Robinson from the Miracle Revival Church, thanked the Board for all they do and read a press release pertaining to an event the Miracle Revival Church will be hosting on May 10th at 6:30 pm. She also extended an invitation to the Commissioners to attend.

Mr. Chris Weiss of Leroy, discussed a recent published news article.

Mr. Leonard Gilbert of Mentor, thanked Commissioners Plecnik and Hamercheck for addressing his concerns and comments regarding increasing property taxes.
