1. The Lake County General Countywide RC-2 Records Retention Schedule. The retention schedule revisions were reviewed by the Prosecutor's Office. The items that were update were Record Series #23-049 to reflect a retention period of 10 years for personnel files; this way the required information regarding sick leave accruals is maintained in the event someone returns to government employment within 10 years of their separation of employment. Record Series #23-066 to include copies of documents as transient records. Also, Record Series #23-074 was added to establish a retention period for workers' compensation fitness waivers.
