NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners, in and for Lake County Ohio, hereby award a bid contract to Specialized Construction, Inc, of 711 Harvard Avenue, Cuyahoga Heights, Ohio 44105, for the County Line Road (CR 141) Reconstruction Project — Phase II for the Lake County Engineer's Department in the amount of \$863,339.00.
